NON-BINDING

- 1. BE IT RESOLVED, That any 8127, or payroll adjustment processed, be itemized and printed on the pay stub with which pay period it was earned in.
- 2. BE IT RESOLVED, That checks be mailed to individuals in the office where they work or home address, if employee wants it that way.
- 3. BE IT RESOLVED, That the NRLCA, in cooperation with the USPS, totally revise the PO 603 upon completion of arbitration of the 2000 contract, and that with the acceptance of each following contract, a review be done to ascertain the necessity of a revision to keep the PO 603 up to date.
- 4. BE IT RESOLVED, That Exhibit 520.c., Form 4240, of the Time and Attendance Manual be changed to read: "Postmaster or Designated Supervisor shall: Complete all information blocks on the upper portion of the form, with the exception of the regular carrier's and relief carrier's Social Security number."
- 5. BE IT RESOLVED, That the Postal Service require all management who deal with rural craft employees to attend forty (40) hours of initial training with sixteen (16) hours of annual training.
- 6. BE IT RESOLVED, That the USPS keep records at the local level of all mail received, volume or piece count, not to exclude pre-sort standards and pre-sort second-class mail.
- 7. BE IT RESOLVED, That the NRLCA be given access to all shipping and receiving logs at the National Bulk Rate Mailing Centers.
